Section 895.14. Change in Title. — Confirmation. When the title or several estate is finally established in any person or persons by a judgment or decree of the district court or by a decree of an appellate court, and there is a change of title in the county in which the estate is located, the clerk of the district court shall certify the same, certify the date of said court, to the county auditor of the county in which said land is located.
