Section 633.14. Change in Title - Certification. Where the title to real estate is changed by the sale or conveyance of or persons by a judgment or decree of the district court or by a decision of an appellate court, or where title to real estate is changed by the operation of law, the auditor of the county, upon the application of the parties, the clerk of the district court shall certify the same under the seal of said court, to the county auditor of the county in which said land is located.
