Section 636, 14. Changes in Title.—Certification. When the title of any land or interest therein is changed by any person or persons, the same shall be certified to the auditor of the county by a judgment or decree of the district court or by a decision of an appellate court, or where title is transferred in a deed, the deed shall be certified to the auditor by the clerk of the district court, and the auditor shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
