Section 608.14. Change in Title. — Certification. Where the title of any real estate is finally established in any person or persons by a judgment or decree of the district court or by a judgment or decree of the county court, or by a judgment or decree of the district court or by a judgment or decree of the county court, and the title is changed by judgment, decree, will, proceeding, or order in probate, the clerk of the district court shall certify the same, and the clerk of the county court shall certify the same, and the same shall be recorded in the county auditor's office in which said land is located.
