

Section 56814. Change in Title. — Certification. Where the title of any land is transferred to any person or persons by a deed, mortgage, judgment or decree of the district court or by a decision of an appellate court, or where title to real estate is changed by any other legal proceeding, the auditor of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
