Section 686, A. Change in Title. — Certification. Where the title of any real estate is finally established in any person or person of a judgment, decree, will, proceeding, or order in any court of a judicial county, or where title to real estate is changed by judgment, decree, will, proceeding, or order in any court of a judicial county, the auditor of the county in which said real estate is located, shall certify to the county auditor of the county in which said land is located.
