Section 696.14, *Change in Title* = Certification. Where the title of any real estate is finally established in any process or by persons by a judgment or decree of the district court or a decision of an appellate court, or where title to real estate is changed by judgment, decree, will, proceeding, or order it is probable, the clerk of the district court shall certify the same to the seal of said court, to the county auditor of the county in which said land is located.
