Section 606-14. Change in Title. - Certification. Where the title to any land is changed by deed or by a judgment or decree of the district court or by a decision of an appellate court, or where title to real estate is transferred by any other means, the auditor shall, upon the filing of the deed, judgment, decree, or other instrument, under the seal of said court, to the county auditor of the county in which said land is located.
