Section 668.14. Change in Title — Certification. Where the title of any real estate is finally determined by a court of law, or by a decision of an appellate court, or where title to real estate is changed by judgment, decree, or other legal process, the county auditor shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
