Section 60514. Change in Title. — Certification. Where the title of any real estate is finally established in any person or corporation, and it is thereafter determined by the court in its decision of an appeal from the assessment of the same, or is changed by judgment, decree, will, proceeding, or order in any court of law, or by the directors of a corporation, the same, under the provisions of this section, shall continue the same, unless the title of said estate shall be changed by the court in any case where the title of said estate is changed by the court in any county in which said land is located.
