Sec. 606.14. Change in Title Certification. Where the title of any real estate is finally established in any person or persons by judgment or decree of a court, and the same is subsequently changed by judgment, decree, will, proceeding, or order in private, the clerk of the district court, or the clerk of the court of appeals, or the clerk of the court, to the county auditor of the county in which said land is located.
