Where the title of any real estate is finally settled in court or by a judgment or decree of the court, or where title to real estate is changed by judgment, decree, will, probate, or otherwise, the auditor of the county in which said land is located, the auditor under the seal of said court, to the county auditor of the county in which said land is located.
