Section 863.14. Change in Title. — Certification. Where the title of any real estate is changed in any proceeding in the courts of this state, or by judgment or decree of the district court or by a decision of an appellate court, or where title to real estate is changed by judgment of the district court, the auditor of the county in which said land is located, under the seal of said court, to the county auditor of the county in which said land is located.
