Sec. 606.14. Change in Title Certification. Where the title to land is transferred by deed, mortgage, or other instrument, the auditor shall certify to the person or persons by judgment or decree of said court or of the supreme court, or where title to said land is transferred by judgment or decree of said court, that the title to said land is changed by judgment, decree, or other instrument, and that the auditor of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
