Section 636.14. Change in Title - Certification. Where the title of any real estate is finally determined by the decision of an appellate court, or where title to real estate is changed by judgment, decree, will, probate, or otherwise, the auditor of the county, upon being so certified, shall, under the seal of said court, to the county auditor of the county in which said land is located.
