Section 686.14. Change in Title. — Certification. Where the title of any real estate is finally established in any person or persons by a judgment or decree of a court of record or by a judgment, decree, will, proceeding, or contract in a probate, the clerk of the court, or where title to real estate is changed by judgment, decree, will, proceeding, or contract in a probate, the clerk of the court, to the county auditor of the county in which said land is located:
