Section 656.14. Change in Title. — Certification. Where the title to any real estate is changed by deed, mortgage, or persons by a judgment or decree of the district court, or by a decision of an appellate court, or where title to real estate is transferred by operation of law, the auditor of the county, or his deputy, shall certify to the clerk of the district court, under the seal of the county, the date of the change, and the name of the person to whom the title is transferred, and the name of the county in which said land is located.
