Section 666.14. Change of Title. Certification. Where the land is sold or conveyed to any person or persons by a judgment or decree of the district court or by a decree of an appellate court, or where title to real estate is changed by a judgment or decree of the district court or by a decree of an appellate court, the clerk of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
