

Section 6361a. Change in Title.—Confirmation. Where the title to land is transferred to any person or persons by a judgment or decree of the district court or by a decision of an appellate court, with proceeding or order in support of such judgment, decree, or decision, or by a deed, mortgage, or other instrument, the clerk of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
