Section 666.14. Change in Title. Certification. Where the title to any real estate has been established by deed or persons by a judgment or decree of the district court or by a decree of an appellate court, or where title to real estate is claimed by a person who is not a party to the original proceedings, the clerk of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
