Section 606, 14. Change in Title. — Certification. Where the title of any real estate is changed by deed, mortgage, or judgment of a court, or by a decree of an appellate court, or where title to real estate is transferred by judgment, decree, or order of a court, the auditor of the county in which said real estate is located, under the seal of said county, to the county auditor of the county in which said land is located.
