Section 898.14. Change in Title. — Confirmation. Where the title of any real estate is finally established to any person or persons by a judgment or decree of the district court or by a judgment of the supreme court, or where title to real estate is changed by a judgment of the district court or by a judgment of the supreme court, or where title to real estate is changed by a judgment of the district court or by a judgment of the supreme court, the clerk of the district court shall certify the same, or the clerk of the supreme court, to the county auditor of the county in which said land is located.
