Where the title of any real estate is finally established in any person or persons by a judgment, decree, will, proceeding, or order in any court of record, or by a judgment, decree, will, proceeding, or order in any court of record, or where title to real estate is changed by judgment, decree, will, proceeding, or order in any court of record, the clerk of the court, or the county auditor of the county in which said land is located,
