

Section 8614. Change in Title. — Certification. Where the title of any real estate is finally established in any person or persons by a judgment or decree of the district court or by a judgment or decree of the county court, and the same is thereafter changed by judgment, decree, will, proceeding or order in probate, the clerk of the district court shall certify the same, and the clerk of the county court shall certify the same, and the county in which said land is located.
