Section 6614. Change in Title - Certification. Where the title of any real estate is finally established in any person or persons by a judgment, decree, will, proceeding, or order in a court of competent jurisdiction, or where title to real estate is changed by judgment, decree, will, proceeding, or order in a court of competent jurisdiction, and the title is finally established, the clerk of said court, to the county auditor of the county in which said land is located.
