Section 606.14. Change in Title. — Certification. Where the title of any real estate is finally established in any person or persons by a judgment or decree of the district court or by a judgment of an appellate court, or by a judgment of the supreme court, or by a judgment of the supreme court, the clerk of the district court shall certify the same, under the seal of the court, to the county auditor of the county in which said land is located.
