Section 565.14. Change in Title. — Certification. Where the title to any land, interest or tenement of the district court has been changed by a judgment, decree or order of an appellate court, or where title to real estate has been changed by a judgment, decree or order of an appellate court, the clerk of the court in which the same was rendered shall certify the same under the seal of said court, to the county auditor of the county in which said land is located.
