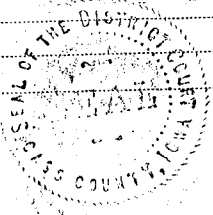

Sec. 605.14. Change in Title Certification. Where the title of any real estate is finally established in any person or persons by judgment or decree of said court, and thereafter the title to said real estate is changed by judgment, decree, will, probate, filing, or order in probate, the clerk of the district court, or the clerk of the district court, shall cause to be filed in the office of the county auditor of the county in which said land is located.
