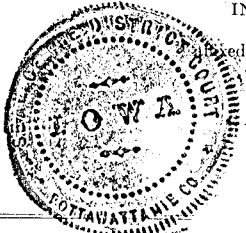

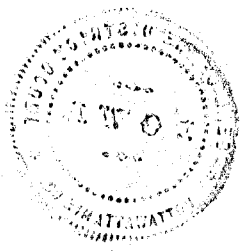

Section 606.14. Change in Title.—Certification. Where the name of a real estate is finally established in any person or persons by a judgment or decree of the district court or by a deed, or by a judgment or decree of the district court or by a judgment of an appellate court, will proceedings, or order in probate, the clerk of the district court shall certify the same, under the seal of the district court, to the county auditor of the county in which said land is located.
