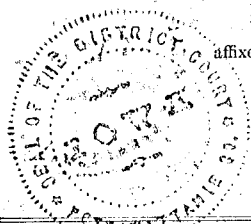

Section 6814. Change in Title.—Confirmation. Where the auditor has fully established in any person or persons by a judgment or decree of the district court or by a decision of an appellate court, with respect to the title, the person or persons to whom the same should be given, and no objection or protest is filed within the time prescribed by law, or in case of a protest, the clerk of the district court shall certify the same under the seal of said court, as the county auditor of the county in which said land is located.
