Where the name of the owner of real estate is changed by or persons by a judgment or decree of the district court or by a decision of an appellate court, or whose title to real estate is transferred to another person by a judgment or decree of the district court, or whose title to real estate is transferred to another person by a decision of an appellate court, the clerk of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
