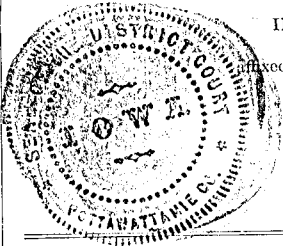

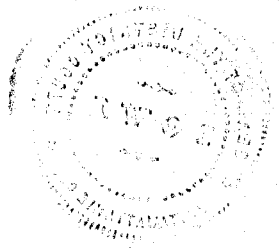

Section 68214. Change in Title. Certification. Where the title to real estate is changed by deed, mortgage or persons by a judgment or decree of the district court or by a decision of an appellate court, or where title to real estate is transferred by a deed, mortgage or persons by a judgment or decree of the district court, the clerk of the district court shall certify, upon the order of the court, the date of the recording of the instrument under the seal of said court, to the county auditor of the county in which said land is located.
